Tuition Consideration Summary

- City Colleges' credit hour tuition rate of \$146 has been unchanged since FY16. City Colleges is the only community college in its region to not increase tuition in the last eight years.
- City Colleges is committed to preserving comprehensive supports for students from free college to mental health, advising, housing and tech supports to the Chicago Roadmap.
- Due to increases in Pell and MAP grants, a full Pell eligible student refund has increased 76% since 2017, while City Colleges tuition has remained flat.
- City Colleges has outlined a tuition proposal for Board consideration: A \$7 per credit hour increase in FY25 (from \$146 to \$153) or \$84 per semester for a full-time student
 - This proposal will lead to a revenue increase of \$12.4M from FY25-27. Maintaining current levels of investment in student supports will require the use of \$15M in cash reserves during FY25-27.
 - If City Colleges were not to use cash reserves, the tuition increase would need to be \$11 per credit hour (up to \$157/credit hour) to maintain full funding. This is not the current proposal.
- City Colleges shared the tuition proposal during the winter of 2023-24 in advance of the February 2024 Board meeting.
- This proposal would take effect in April 2024. However, students who register by June 30, 2024 will receive an early registration discount at the current \$146/hr rate. Students registering July 1 and after would receive the proposed \$153/hr rate.

Tuition Plan Proposal

The proposed tuition increase for FY25 will result in the following credit hour rates:

- Impact to full-time* in-district student in FY25 would be a semester increase of \$84 or an annual increase of \$168. (Based on a full-time student taking 12 credit hours per term.)
- There will be an early registration discount for students who register by June 30, 2024. Registrants by this date will still be able to receive the current \$146/hr rate. Those registering July 1 and thereafter will be at the \$153/hr rate.

Tuition and Fees Changes from FY2016-FY2024


Since our last tuition increase, City Colleges has gone from the **highest** tuition rate when compared to neighboring peers, to the **second lowest** rate in 2024

Students have been eligible for more money in their pocket with Pell Grant & MAP allotment increasing, while CCC tuition has remained the same




- City Colleges tuition rate has remained unchanged since 2016
- In 2024, a full Pell eligible student will have a 76% larger refund than in 2017 to help cover life expenses
 - Pell increased by 27% or \$1,580 since 2017
 - MAP increased 85% or \$1,542 over the same time period

In FY25, the average refund amount for the full-time student would be reduced by \$168 to \$2,524 (assuming all else is equal)



- Pell/SEOG/MAP make up more than half of the resources available to students
- "Third Party" payments such as: CHA, AON, and Department of Human Services
- "Other Waivers" includes \$800k in athletic waivers and \$400k in employee/dependent waivers
- "Other Grants" include WEI, Early Childhood Access, and WIA

- New rate takes effect
- Student discount takes effect through June 30, 2024

July 1, 2024
