#### **ORIGINAL TERM:**

In accordance with Board Report 34336, the original term of the purchase commenced on October 7, 2021 and shall end on June 30, 2024 with the option to renew for one (1), two-year period.

#### **RENEWAL TERM:**

The renewal term of the purchase shall commence on July 11, 2024 and shall end on June 30, 2026.

#### **SCOPE OF SERVICES:**

Production Distribution Companies, Inc. will provide filter supplies for HVAC systems on an as needed basis.

#### **BENEFIT TO CITY COLLEGES OF CHICAGO:**

Utilizing Production Distribution Companies, Inc. to provide filter supplies for HVAC systems through a joint purchasing agreement with Cook County is a cost-effective method to obtain the necessary supplies on an as needed basis and to provide for the continued operation of a safe and healthy educational environment for students, faculty and staff.
