**THE CHANCELLOR RECOMMENDS:**

that the Board of Trustees authorizes the Chair, upon final approval of the General Counsel of the legal form of such agreement, to exercise the option to renew the agreement with Mundo Electric Company to maintain and repair the electrical systems in all District facilities on an as needed basis for the period July 7, 2024 through July 6, 2025 for a total cost not to exceed \$1,500,000.

**ORIGINAL TERM:**

The original term commenced on July 7, 2021, and shall end on July 6, 2024, with an option to renew for an additional two (2) one-year terms.

**FIRST RENEWAL TERM:**

The first renewal term of the agreement shall commence on July 7, 2024, and shall end on July 6, 2025, with one (1) remaining option to renew for one-year.

**SCOPE OF SERVICES:**

Mundo Electric Company will provide routine and emergency repairs and parts for the colleges as needed to include all wiring for lighting, power, panels, and termination points.

**BENEFIT TO CITY COLLEGES OF CHICAGO:**

The Office of Administrative and Procurement Services has reviewed this request for services and has determined that it would be in the best interest of the District to continue to work with Mundo Electric Company to ensure that electrical systems will be properly installed, maintained, and repaired. Based on review of past needs of the campuses and unpredictable

equipment failures often needing emergency repairs and or parts, it is recommended to renew the work with Mundo Electric Company.

**VENDOR SELECTION CRITERIA:**

Specifications were prepared by District Procurement staff and Sealed Bid #SN2104 was publicly advertised on March 26, 2021, to solicit bids to provide hourly rates for the required work for a three (3) year period with an option to renew for an additional two (2) one-year terms. The bid was sent to eighty (80) companies. Two (2) companies responded on April 16, 2021: 1) Broadway Electric Inc. and 2) Mundo Electric Company.
