**WHEREAS**, City Colleges of Chicago had an approved agreement with Occupational Health Centers of Illinois, P.C., d/b/a, Concentra Medical Centers for Illinois Department of Transportation (IDOT) certified pre-drug screens, physical examinations and random drug test services as needed to support Olive-Harvey College's Commercial Driver's License and Aviation Career Programs & Continuing Education programs, covering the period September 15, 2021 through August 15, 2023 for a cost not to exceed \$15,000;

**WHEREAS**, The Office of Academic Affairs- Adult Education through their Career Grow Chicago Grant (DFSS) Project (#108312350) had an Adult Education Bridge student receive a drug test and physical on January 9, 2024.

**WHEREAS**, Occupational Health Centers of Illinois, P.C., d/b/a, Concentra Medical Centers invoiced City Colleges of Chicago for services rendered in the amount of one hundred thirty-seven dollars ( \$137.00) without a professional services agreement or purchase order.

**WHEREAS**, The Office of Academic Affairs- Adult Education, recommends payment to Occupational Health Centers of Illinois, P.C., d/b/a, Concentra Medical Centers in the amount of one hundred thirty-seven dollars ( \$137.00).

**WHEREAS**, The Office of Academic Affairs- Adult Education will have a new contract with Occupational Health Centers of Illinois, P.C., d/b/a, Concentra Medical Centers with an effective date of October 1, 2024 in order to request pre-drug screens, physical examinations and random drug test services for students and to remain compliant with CCC purchasing and contracting policies.
