#### THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair, upon final approval of the General Counsel as to the legal form of such agreements, to execute an agreement with Bus and Truck of Chicago, Inc to provide Equipment Services, Maintenance and Repair as detailed below for Olive-Harvey College CDL Training Vehicles, for the period from December 9,2024 through December 8, 2025, at a total cost not to exceed \$100,000.

#### **ORIGINAL TERM:**

Pursuant to board report 34377, the term of this agreement shall began no sooner than December 9, 2021, and shall end on December 8, 2024, with options to extend for two (2) one (1) year periods.

#### 1<sup>st</sup> TERM RENEWAL:

The term of this agreement shall commence on December 9, 2024, and shall end on December 8, 2025, with one (1) additional one-year renewal option.

#### **SCOPE OF SERVICES:**

The vendor listed above will provide Equipment Repair Services, Mobile Technician Services, Preventative Maintenance Services, and Department of Transportation Certification inspections for the Olive-Harvey College fleet of CDL training vehicles.

#### **BENEFIT TO CITY COLLEGES OF CHICAGO:**

The services will allow Olive-Harvey College to maintain a fleet of good working order vehicles for the CDL training program. This maintenance and repair program will support the goals of keeping the training vehicles operational, in good repair, and well maintained. The Department of Transportation Certification inspections will keep the vehicles in compliance with the law.

#### **VENDOR SELECTION CRITERIA:**

Specifications was prepared by District Procurement staff and Bid #SH2108 was publicly advertised Friday, October 22, 2021. The bid was to provide equipment services, maintenance and repair for Olive-Harvey College. Forty-one (41) vendors were contacted and on November 4, 2021, one (1) company responded: 1) Bus and Truck of Chicago Inc.
