TERM:

The term of the purchase shall begin on April 3, 2025, and shall end on June 30, 2026.

SCOPE OF SERVICES:

CDW-G will provide various computer equipment and related services to support the expansion of technology equipment at Kennedy-King College. The purchase of updated Technology equipment and computer hardware technology will support classroom instruction, meet the student learning outcomes, and provide the necessary skills to enter the workforce.

BENEFIT TO CITY COLLEGES OF CHICAGO:

The use of CDW-G's products will allow Kennedy-King College to train the students in the most current Technology. This preparation will provide the necessary skills to students and in turn increase enrollment, retention, and completion of all programs.

VENDOR SELECTION CRITERIA:
