RESOLUTION

**TO AUTHORIZE AN INTERGOVERNMENTAL DATA-SHARING AND COLLABORATION AGREEMENT BETWEEN
THE BOARD OF EDUCATION OF THE CITY OF CHICAGO AND THE BOARD OF TRUSTEES OF COMMUNITY
COLLEGE DISTRICT 508
OFFICE OF ACADEMIC AFFAIRS- EDUCATIONAL QUALITY**

WHEREAS, following its implementation in 2019 and leading up to academic year 2025 leaders from both City Colleges of Chicago (CCC) and Chicago Public Schools (CPS) collaborated to build and sustain flexible pathways towards two-year degrees, this “Roadmap” provided a shared agenda and set of goals and strategies to guide the partnership between CPS and CCC from 2019-2025; and

WHEREAS, Together, CPS and CCC have impacted incoming first year students by expanding programming available in high school. This has led to increases in college readiness in English and math, enrollment at CCC (Early College, credit, and Adult Ed), college course pass rates, access to credit-bearing courses, and access for students with disabilities and students attending Options high schools; and

WHEREAS, Since the launch of the original Roadmap, CCC has implemented policy changes that have streamlined the application, placement, and enrollment process for students; and

WHEREAS, to effectively and efficiently ensure that students at CPS can more easily access postsecondary success through CCC, and so that our teams might progress monitor the strategies implemented to reach the goals of the Roadmap, it is critical that CPS and CCC are able to share student information; and

WHEREAS, CPS and CCC previously shared students information for the purposes of streamlining the aforementioned processes aimed at access, the evolved partnership between our institutions will ensure success as student continue their postsecondary in pursuit of their associate’s and potential bachelor’s at a transfer institution. By ensuring enrolled students engage with support services on campus, we hope to create a continued “Roadmap” from high school through completion of their associate’s degree and planning of next steps; and

WHEREAS, due to the partnership expanding, it necessary to update the means by which we collaborate and share data to guarantee college and career access for all students in Chicago; and

NOW THEREFORE BE IT RESOLVED, by the Board of Trustees of Community College District No. 508, County of Cook and State of Illinois, hereby authorizes the Chair, upon final approval of the General Counsel of the legal form of such agreement, to execute an intergovernmental agreement between the Board of Education of the City of Chicago and the Board of Trustees of Community College District 508 for a period beginning August 5, 2025 and continuing for two (2) years after the commencement date with three (3) options to renew for one (1) year each.
