THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair, upon final approval of the General Counsel as to the legal form of such agreement, to exercise an agreement with Health Care Service Corporation d/b/a Blue Cross Blue Shield of Illinois ("BCBS") to provide administration services for the City Colleges of Chicago ("CCC") self-insured group medical related to the District's fully-insured Health Maintenance Organization (HMO) Medical Plan for the period from January 1, 2026 through December 31, 2029 at an annual cost of \$16,000,000 and not to exceed \$64,000,000 for the term of the agreement.

TERM:

The agreement shall commence on January 1, 2026, and end on December 31, 2029.

SCOPE OF SERVICES:

BCBS provides fully insured services. Costs include claims and administrative fees for eligible active and retired CCC employees covered under the HMO.

BENEFIT TO CITY COLLEGES OF CHICAGO:

The Office of Human Resources participated in a Joint Request for Proposal (RFP) with the City of Chicago and several sister agencies. It is advantageous to the District to leverage the joint purchasing agreement with these multiple organizations. This leverage resulted in cost savings on the administrative fees while maintaining the "best in class" health care services.

VENDOR SELECTION CRITERIA:

The contract being utilized as part of the joint purchasing agreement has been advertised and was awarded in July 2020 in accordance with the joint procurement procedures of CCC, other sister agencies and the City of Chicago (Specification No. CBO 2019-001). This agreement has been extended through the City of Chicago as part of our joint procurement agreement.

The Office of Procurement Services has reviewed the proposed compliance plan and determined the Vendor has complied with the Board Approved MBE/WBE Contract
