THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair, upon final approval of the General Counsel of the legal form of such agreement, to exercise an agreement with Agile Sports Technologies, dba HUDL for athletic recording and video system for the period of January 1, 2026, to December 31, 2026, at a total cost not to exceed \$53,751 for the term of the agreement.

TERM:

The term of this agreement shall commence on January 1, 2026, and continue through December 31, 2026.

SCOPE OF SERVICES:

Agile Sports Technologies, Inc., dba HUDL will supply, install, and provide maintenance services for automated video camera systems (VCS) and all related software at six (6) campuses (Harold Washington does not have sports teams). The VCSs will record all games and practices on a day-to-day basis for ondemand viewing. The VCS equipment will provide CCC sports events with live streaming and post-event footage. Video footage will be available to sports coaches and student athletes for video editing, analysis, storage, and recruiting purposes.

BENEFIT TO CITY COLLEGES OF CHICAGO:

HUDL provides City Colleges of Chicago (CCC) with a centralized and data-driven athletics management platform that enhances student-athlete development, recruitment, and institutional visibility. Through its video analysis, performance tracking, and cloud-based sharing tools, HUDL allows coaches to efficiently review game footage, develop strategies, and support athlete growth while maintaining compliance with institutional and FERPA standards. The platform strengthens CCC's ability to showcase athletic programs by producing professional-quality highlight reels and exposure opportunities that help student-athletes transfer to four-year universities. Additionally, HUDL promotes consistency and collaboration across CCC's seven colleges, streamlining operations, reducing redundant technology costs, and elevating the district's athletics brand. By integrating HUDL, CCC positions its athletics programs to operate at a more competitive and professional level while advancing student success and institutional recognition. The system also directly supports institutional compliance with NJCAA Region 4 competition and film exchange protocols, where HUDL is the recognized and required industry standard.

VENDOR SELECTION CRITERIA:

Pursuant to State law, all contracts for the purchase and delivery of data processing equipment, software and services are exempt from the District's competitive bidding requirements. Prior attempts to secure a vendor via competitive solicitations have resulted in no bidders.

MBE/WBE COMPLIANCE:

The Office of Procurement Services has reviewed the proposed compliance plan and recommends a full waiver of the Board Approved MBE/WBE Contract Participation Plan due to the nature of the agreement (athletic recording and video software) and the absence of subcontracting opportunities.

GENERAL CONDITIONS:

Inspector General – It shall be the duty of each party to the agreement to cooperate with the Inspector General for City Colleges of Chicago in any investigation conducted pursuant to the Inspector General's authority under Article 2, Section 2.7.4(b) of the Board Bylaws.

Ethics — It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board's Ethics Policy adopted January 7, 1993, and as amended by the Board.

Contingent Liability – Pursuant to Section 7-14 of the Illinois Public Community College Act, all agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal year is subject to appropriation in the subsequent fiscal year.
