TERM:

The term of this agreement shall begin no sooner than February 6, 2025, and shall end on February 1, 2026.

SCOPE OF SERVICES:

West Jeff Auto Sales, LLC is providing valuable support to Kennedy-King College's Automotive Program through vehicle procurement services. They have facilitated competitive pricing for electric vehicles, addressing increased costs due to market conditions and production changes. Despite recent price fluctuations, West Jeff Auto Sales, LLC continues to work with Kennedy-King College to ensure timely delivery and cost transparency. Their commitment helps equip the program with modern vehicles, aligning with industry standards and enabling students to gain hands-on experience with the latest automotive technologies

BENEFIT TO CITY COLLEGES OF CHICAGO:

The partnership with West Jeff Auto Sales, LLC provides City Colleges of Chicago with access to competitively priced electric vehicles, enhancing the educational resources available for the Automotive Program. All bids were reviewed by staff and all vendors submitted information in accordance with the bid requirements. Staff recommends acceptance of the bid received to award West Jeff Auto Sales, LLC.

MBE/WBE COMPLIANCE:

The Office of Procurement Services has reviewed the proposed compliance plan and recommends a full waiver of the Board Approved MBE/WBE Contract Participation Plan due to the nature of the agreement (EV vehicle purchase) and the absence of subcontracting opportunities.

GENERAL CONDITIONS:

Inspector General - It shall be the duty of each party to the agreement to cooperate with the Inspector General for City Colleges of Chicago in any investigation conducted pursuant to the Inspector General's authority under Article 2, Section 2.7.4(b) of the Board Bylaws.

Ethics — It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board's Ethics Policy adopted January 7, 1993, and as amended by the Board.

Contingent Liability – Pursuant to Section 7-14 of the Illinois Public Community College Act, all agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal year is subject to appropriation in the subsequent fiscal year.
