THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair, upon final approval of the General Counsel as to the legal form of such agreements, to authorize the execution of an agreement with Zogo Technologies, LLC for an enterprise data warehouse and business intelligence solution for the period from August 1, 2025 through July 31, 2028, at a total cost not to exceed \$840,614.40.

TERM:

The term of this agreement shall begin on August 1, 2025, and shall end on July 31, 2028.

SCOPE OF SERVICES:

Zogo Technologies, LLC will deliver an enterprise data warehouse and business intelligence platform to CCC, enabling standardized data analysis and visualization to support informed decision-making and actionable strategies. This will help reduce costs, uncover new program opportunities, streamline inefficient processes, boost enrollment, and ensure sufficient resources for student education.

Zogo Technologies analytics platform will:

- Integrate and store data from Oracle PeopleSoft Campus Solution, flat files and SQL platforms like MS SQL and MySQL.
- Offer an efficient environment for fast and complex data processing.
- Enable self-service reporting for users to analyze trends, track KPIs, and handle ad hoc requests without IT or analyst support.
- Support the development of reports with both aggregate and detailed data, including drill-down capabilities.
- Facilitate self-service dashboards to visualize and explore live and historical CCC data, making key insights easily accessible.
- Allow storage and reporting of data in time-based snapshots (monthly, quarterly, yearly).
- Ensure user-specific security to restrict access to datasets, BI features, and applications based on roles or group membership.
- Include an enterprise license for unlimited use of the business intelligence tool across CCC.

BENEFIT TO CITY COLLEGES OF CHICAGO:

The data warehouse and business intelligence platform enable CCC to integrate, analyze, and display data in ways that enhance decision-making and drive actionable strategies. These strategies will aim to cut costs, identify new program opportunities, streamline processes, increase enrollment, and ensure sufficient resources for student education.

Key anticipated benefits include:

- Improved accuracy, timeliness, and effectiveness in decision-making.
- Easier access to relevant data to support informed decisions.
- Enhanced flexibility to adapt to the evolving needs of decision-makers at all levels.
- Streamlined handling of internal and external information requests.
- Empowering users to generate their own reports.

VENDOR SELECTION CRITERIA:

Pursuant to State Law, all contracts for the purchase and delivery of data processing equipment, software and services are exempt from the District's competitive bidding requirements.

MBE/WBE COMPLIANCE:

The Office of Procurement Services has reviewed the proposed compliance plan and has determined that the vendor has complied with the Board Approved MBE/WBE Contract Participation Plan with a recommended full waiver of the 7% WBE goal.
