#### THE CHANCELLOR RECOMMENDS:

That the Board of Trustees authorizes a purchase order with Advanced Technologies Consultants for the purchase of training equipment in the Advanced Manufacturing and Data Center Operating Programs from the period beginning May 1, 2025, and ending April 31, 2026, at a total cost not to exceed \$125,000.

#### TERM:

The term of the purchase shall commence on May 1, 2025 and ends on April 31, 2026

#### **SCOPE OF SERVICES:**

Advanced Technologies Consultants will provide Engineering Technology training equipment to support hands on training in Advanced Manufacturing and Data center Operator programs at Daley College. Equipment will provide electrical controls, industrial and commercial mechanical colling process training on equipment representative of actual commercial and industrial equipment. The college currently has board approved vendors that provide repair and maintenance services for all program equipment.

#### **BENEFIT TO CITY COLLEGES OF CHICAGO:**

The equipment will allow the expansion and enhancement of training programs at Daley College to add Data Center Operator training and to meet the needs of employer partners for their skill industrial maintenance technician skills needs. This equipment will be utilized in both

credit and on credit programs and workforce development programs related to advanced manufacturing and Engineering Technology.

#### **VENDOR SELECTION CRITERIA:**

In accordance with the sole source policy and procedures, this purchase is exempt from the district's competitive bidding process.

#### MBE/WBE COMPLIANCE:

The Office of Procurement Services has reviewed the proposed compliance plan and recommends a full waiver of the Board Approved MBE/WBE Contract Participation Plan due to the nature of the purchase (engineering technology training equipment) and the absence of subcontracting opportunities.

#### **GENERAL CONDITIONS:**

Inspector General - It shall be the duty of each party to the agreement to cooperate with the Inspector General for City Colleges of Chicago in any investigation conducted pursuant to the Inspector General's authority under Article 2, Section 2.7.4(b) of the Board Bylaws.

Ethics — It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board's Ethics Policy adopted January 7, 1993, and as amended by the Board.

Contingent Liability – Pursuant to Section 7-14 of the Illinois Public Community College Act, all agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal year is subject to appropriation in the subsequent fiscal year.
