Through this new competitive grant, Kennedy-King College proposed project aims to develop and expand community-based experiential training for individuals preparing to become mental health workers, peer support specialists, and other behavioral health paraprofessionals. With a specific focus on pre-service training, the initiative will integrate didactic learning and hands-on field placements to enhance skills and knowledge. Special attention will be given to addressing the needs of underserved populations, including children, adolescents, and transitional-age youth, particularly those affected by trauma and at risk for behavioral health disorders. The concept revolves around establishing a robust Level 1 pre-service training program that integrates classroom instruction with real-world experiential learning. The program will prepare trainees to work in interprofessional teams within integrated behavioral health and primary care settings. Partnerships with community-based organizations will enable practical field placements, providing trainees with real-world exposure while addressing workforce shortages in underserved communities

The Workforce Empowerment Initiative grant aims to aid students from communities marked by high unemployment and economic disparities. Specifically, it targets those seeking to complete certain health science or nursing programs at Malcolm X College, designed to be finished within a year, facilitating immediate entry into the workforce. Of the students served, they must be individuals residing in disproportionately impacted areas. With this continuation grant, MXC helps to address educational and employment inequities in disproportionately impacted communities on the West Side. Though Project MPACT career development support for students who have historically faced barriers to workforce entry, limited access to education and career pathways, and underrepresentation in high-demand high-wage industries. This initiative also supports the urgent need for skilled professionals in the healthcare sector.

<p>The Workforce Empowerment Initiative provides individuals with the opportunity to attain a college credential in a high demand sector/industry to access jobs that pay 30% above the regional living wage or on an educational pathway leading to 30% above the regional living wage. The purpose of this grant is to create, support, or expand short-term (one year or less) workforce (credit and/or noncredit) training opportunities in high-need communities focused on specific sectors with identified workforce gaps. For this continuation grant, Olive-Harvey's Project Evolve will target students across nine neighborhoods experiencing unemployment. By expanding 8-13 programs with Transportation, Distribution and Logistics, Energy, Technology and Manufacturing Sectors, including welding, electric vehicle infrastructure, network systems and technology, and criminal justice to respond to growing demand in high-wage sectors. <p>With the support of grant funds from the Illinois Community College Board (ICCB), Wilbur Wright College will lead the Workforce Empowerment Initiative Consortium (WEI-C) with partner Harold Washington College to provide CCC students with an educational resource that supports the mission and vision of the city colleges of Chicago. This collaboration is the first of its kind and will help expand the reach of educational services and short-term training program access to students. WEI-C also supports the work lifted in CCC's core values. The WEI-C will prioritize funding to serve students from the communities of Austin, North and South Lawndale, Humboldt Park East and West Garfield</p>				

Park, Washington Park, Englewood, and South Chicago. Those impacted from this grant work will be residents from the city of Chicago, who are adults aged 18 and over and individuals residing in Disproportionately Impacted Areas.

The grant funds will be used to help service at least 165 students from targeted underserved community areas to provide an opportunity toward economic mobility through short-term, less than one year in-demand career pathways. The outcomes of this grant will include having student completers in the program who will earn college and/or industry recognized credentials which increases chances of employment.

For this continuation grant, Kennedy-King College will continue advancing equity focusing on individuals from Englewood and surrounding communities disproportionately affected by systemic barriers to education and employment. With the support of grant funds from the Illinois Community College Board (ICCB), Richard J. Daley will expand its Technology Works (TW) initiative, building on past success in Advancing Manufacturing training, soft skills development, and student support to boost economic mobility in Chicago's south and west sides. The program will adapt to local employer needs, offering higher starting wages and innovative student-employer connections to improve employment outcomes. TW is expanding its offering to meet the needs of local industry partners and will offer stackable credential pathways, including CNC Operator, Welding Operator, Electrical Maintenance Technician, Chemical Process Operator, Solar PV Technician, BC Manufacturing Technician, Foundations of Manufacturing, and Food Manufacturing Technician. Richard J. Daley will continue to collaborate with manufacturing companies and engage employers through advisory committees, job fairs, and upskilling programs to ensure WEI participants possess the soft skills and technical competencies to succeed.

The Illinois Apprenticeship Expansion Program aims to increase Registered Apprenticeship opportunities for career seekers while supporting employers by funding Intermediaries. These Intermediaries are key players in developing and administering programs, offering direct services to participants enrolled in Registered Apprenticeship Programs (RAPs) or Pre-Apprenticeship Programs. The Illinois Department of Commerce and Economic Opportunity (ILDCEO) will prioritize programs in non-traditional, in-demand RAPs and Pre-Apprenticeships leading to RAPs, including healthcare, information technology, finance and business, architecture and engineering, creative industries, and

public sector and government. CCC is a proven apprenticeship intermediary, recently receiving Department of Labor distinction as such - as an Apprenticeship Ambassador. Funds will be used to supplement a recently approved staffing commitment from Chancellor - to grow the Workforce Solutions team by three members. Additional funds will be needed to support employers (i.e. covering portions of apprentices' wages or training-tuition) and apprentice wrap-around supports (uniforms, transportation, emergency funds). CCC students (apprentices) districtwide and employers will be impacted. The grant fuels CCC's recent commitment to scaling apprenticeships districtwide, to provide more transformational career opportunities for students, while also helping to meet the regions and employers labor market demands.

Kennedy-King College was awarded funds to develop the Pathways in School Based Mental Health partnership with local K-12 schools and four-year universities. This collaborative funding from the CME Group Foundation and the Steans Family Foundation addresses the statewide shortage of school social workers, counselors, and psychologists, with a focus on underserved communities such as Chicago. The initiative will create accelerated, culturally responsive educational pipelines aimed at reducing time-to-degree, increasing workforce diversity, and lowering financial barriers. Grant funds will support curriculum development, faculty training, student support services, and employer partnerships to facilitate earn-and-learn opportunities. Up to 10% of the budget may be allocated for scholarships or emergency funding to improve accessibility. This project is expected to strengthen mental health services in schools and improve outcomes for students and communities while supporting diverse students entering the mental health workforce. This new competitive award will allow City Colleges of Chicago to build on multi-year, system-wide investments in its healthcare programs. These investments are a response to student demand, the needs of health system partners, and market projections in this high-growth sector. This opportunity from Chicago Community Trust (CCT) will be a pass-through to CCC to focus on building a robust workforce pipeline with emphasis on roles that have potential to lead into a career pathway through guided support to programs such as CCC's Patient Care Technician to Associate Degree in Nursing Pathway Program. Funding will bolster the capacity of CCC and its healthcare partner Cook County Health (CCH) to tailor and expand educational programs in the health professions. This will be supporting individuals' career entry and pathway to generating greater household wealth. This is a tangible, achievable way that we can collaboratively increase the financial security and health of individuals from primarily from Black and Latine communities.

This Transfer Innovation Impact Model (TIIM) was awarded to Chicago State University in collaboration with Olive-Harvey as a subaward project to seeks to serve students on the southeast side of Chicago area. The primary source of funding is from Searle Funds at Chicago Community Trust. The goal is to support STEM and allied health students as they matriculate through both institutions. The planning grant will focus on clarifying existing academic and career challenges for students through surveys and focus groups with students, their families, and advisors at both institutions. The grant will also aid the development of relevant student supports focused on both decreasing losses of course credits and time to degree completion paired with providing students with the ability to explore multiple career options and increasing students' sense of belonging in the health and STEM professional fields. Students on the pathway to earn an AAS will be impacted. Enhancing transfer opportunities is a key priority for CCC. The funding from this grant will strengthen our partnership with CSU and create more pathways for successful transfers.

Phi Theta Kappa (PTK) will be providing one-on-one career transfer, and scholarship coaching services to the Institutions Honors Program/PTK members. Kennedy-King will be able to continue advisor support for their PTK chapter, provide induction ceremonies, establish a PTK Honors Program, and assess student outcomes. This

collaboration will build on honors curriculum, activities, and experience to promote self-efficacy, transfer efficacy, workforce readiness, scholarship attainment, leadership through strong peer and faculty engagement and support from PTK and its partners.

REpowering Schools has awarded Professor Malik Abunaemeh in the Renewal Energy Education Awards to prepare the next generation of clean energy innovators who can meet workforce demands while contributing to sustainability and equity. This award will allow CCC to embed renewable energy experimentation into physics courses. Students will explore solar and wind technologies through project-based learning, including system design, performance testing, and prototype development. The program emphasizes innovation and equity, ensuring underrepresented students gain access to cutting-edge tools, mentorship, and professional development opportunities. Funds will support the purchase of commercial-grade renewable energy kits, research equipment, and materials for student projects. A portion will cover conference travel to enable students to present findings at regional and national meetings, while publication fees will ensure that student-driven research is shared broadly. Collectively, these investments will create a replicable model for renewable energy education at CCC.

The Flight Path initiative is part of the Spark of Science @My Library project, funded by Tangled Bank Studios at the Howard Hughes Medical Institute. The focus is the science of birds and bird migration, with a goal to raise awareness about bird migration and promote community involvement in bird conservation. This grant will provide funds and resources for library programming, including films, bird watching kits, educational handouts, bird safety tape for windows, in addition to \$500 to help promote the programs. This new award will allow Richard J. Daley College to invite students and community members to watch the Wild Hope films, set up book displays in the library highlighting the birds we'll see in our urban environment, and partner with local birding groups to lead bird walks through the two large Chicago Public Parks nearest AVI and Daley (McKinley Park and Marquette Park). The \$500 stipend can purchase additional sets of binoculars that can be loaned out to students and updated local bird guides for the library. The impact of this grant will be felt by not only students who attend the programs or use any of the resources, but the whole community.
