**RESOLUTION
AUTHORIZING AN AMENDMENT FOR MALCOLM X COLLEGE TO ENTER INTO A SUBAWARD
INTERGOVERNMENTAL AGREEMENT WITH FLORIDA INTERNATIONAL UNIVERSITY
AMENDMENT TO BOARD REPORT #35749**

WHEREAS, the Board of Trustees of Community College District No. 508, County of Cook and State of Illinois (“Board”) is authorized to enter into intergovernmental agreements in furtherance of the mission of the City Colleges of Chicago (“CCC”); and

WHEREAS, Malcolm X College (“MXC”), a college of CCC and a designated Hispanic-Serving Institution, has demonstrated expertise in STEM education, faculty development, and collaborative community-based initiatives; and

WHEREAS, Florida International University (“FIU”), a public research university and Hispanic-Serving Institution, is the lead institution for the UNIDOS HSI Program Network Resource Center for Community Coordination, funded by the National Science Foundation; and

WHEREAS, FIU has requested Malcolm X College to serve as a sub awardee to support the UNIDOS Network Resource Center, which is intended to strengthen coordination, capacity building, co-design, and communication across the national HSI community; and

WHEREAS, pursuant to the proposed subaward agreement, Malcolm X College will support project activities that include convening and connecting HSI stakeholders, participating in capacity-building initiatives such as grantsmanship workshops and faculty development, engaging in co-design activities including listening sessions and advisory committees, supporting communication efforts to disseminate effective practices, and contributing to required interim, annual, and final reporting to the National Science Foundation, consistent with the approved scope of work;

WHEREAS, the original grant terms listed in resolution 35749 were October 1, 2025 through September 30, 2029; and

WHEREAS, the grant period should be revised to October 1, 2024 through September 30, 2029; and

NOW THEREFORE BE IT RESOLVED, that the Board of Trustees of Community College District No. 508, County of Cook and State of Illinois, authorizes the Chair, upon final approval of the General Counsel as to the legal form of such an amendment, to amend the grant term date

in the previous resolution 35749 to align with the subaward agreement with Florida International University for Malcolm X College to serve as a sub awardee on the UNIDOS HSI Program Network Resource Center for Community Coordination. Further, let it be resolved that the Board ratifies and authorizes any actions necessary for the execution of the grant objectives during the grant term of October 1, 2024, through September 30, 2029, in which Florida International University agrees to provide \$44,476.00 to Malcolm X College for use in connection with the program, consistent with applicable laws, regulations, and Board policies.
