RESOLUTION

**AUTHORIZING MALCOLM X COLLEGE TO ENTER INTO A SUBAWARD INTERGOVERNMENTAL
AGREEMENT WITH CHICAGO STATE UNIVERSITY**

WHEREAS, the Board of Trustees of City Colleges of Chicago (“Board”) is authorized under applicable law to enter into intergovernmental agreements in furtherance of the educational mission of the City Colleges of Chicago (“CCC”); and

WHEREAS, Malcolm X College (“MXC”), a college of CCC, serves as the District’s Center of Excellence for Healthcare Education and has demonstrated expertise in STEM education, faculty professional development, curriculum design, and student support services; and

WHEREAS, WHEREAS, Chicago State University (“CSU”), a public four-year institution of higher education, is the lead institution for the Collaborative Research: Developing STEM Education Reform Leaders through a Multidisciplinary and Cross-Institutional Community of Transformation project, supported through external grant funding; and

WHEREAS, Chicago State University has requested Malcolm X College to serve as a sub-awardee to support the implementation of project activities designed to strengthen STEM education through collaborative faculty engagement, instructional innovation, and curriculum reform; and

WHEREAS, pursuant to the proposed subaward agreement, Malcolm X College will support project activities that include faculty participation in professional learning communities, development and refinement of STEM instructional practices, collaboration on curriculum and instructional materials, engagement in data collection and evaluation activities, and participation in dissemination efforts, consistent with the approved scope of work;

WHEREAS, Malcolm X College will manage and administer the grant funds; and

WHEREAS, the Illinois Community College Board will provide \$108,398.00 from Chicago State University-53249A for operating costs during fiscal year 2026/2027.

NOW THEREFORE BE IT RESOLVED, that the Board of Trustees of Community College District No. 508, County of Cook and State of Illinois, authorizes the Chair, upon final approval of the General Counsel as to the legal form of such agreement, to execute a subaward agreement

with Chicago State University for Malcolm X College to serve as a sub awardee on the Developing STEM Education Reform Project. Further, let it be resolved that the Board ratifies and authorizes any actions necessary for the execution of the grant objectives during the grant term of September 15, 2025, through August 31, 2026, in which Chicago State University agrees to provide **\$108,398.00** to Malcolm X College for use in connection with the program, in accordance with applicable laws, regulations, and Board policies.
