### CONTINUING EDUCATION ENROLLMENT SYSTEM GIDEON TAYLOR CONSULTING, LLC THE OFFICE OF ACADEMIC AFFAIRS DISTRICT WIDE (RENEWAL)

#### **THE CHANCELLOR RECOMMENDS:**

that the Board of Trustees authorizes the Chair, upon final approval of the General Counsel as to the legal form of such agreements, to authorize the renewal of an agreement with Gideon Taylor for the license and implementation of GT eForms and WebUX to develop a student-centered enrollment system for Continuing Education the period for the period commencing no sooner than April 3, 2026, and will end on April 30, 2028, at a total cost not to exceed \$200,000.

#### **ORIGINAL TERM:**

In accordance with board report 35333, the original term of the agreement commenced on April 3, 2025, and will end on April 2, 2026, with the option to renew for an additional two (2) year term.

#### **FINAL RENEWAL TERM:**

The term of this agreement shall begin no sooner than April 3, 2026, and shall end on April 30, 2028. The subscription term shall begin on the 1<sup>st</sup> of the month following execution of the agreement.

#### **SCOPE OF SERVICES:**

Gideon Taylor shall provide the GT eForms and WebUX software solutions to facilitate continuing education enrollment at City Colleges of Chicago. The solution includes user-friendly enrollment forms within PeopleSoft, single-session student enrollment capabilities, dynamic course search functionality, marketing content integration, and direct course enrollment links from external marketing materials. Utilizing the GT solutions, students are able to self-enroll in continuing education courses through an intuitive interface while maintaining full integration with CCC's existing PeopleSoft Campus Solutions system. The scope includes software subscription renewal fees and necessary consulting and training fees to cover unforeseen changes or enhancements to the system, to ensure the continued success of our Continuing Education enrollment solution, utilizing both GT eForms and WebUX products.

#### **BENEFIT TO CITY COLLEGES OF CHICAGO:**

The implementation of Gideon Taylor's GT eForms and WebUX solutions significantly improves CCC's continuing education enrollment process by allowing students to self-enroll in Continuing Education courses. With the Gideon Taylor's GT eForms and WebUX solution, CCC has greatly

increased its ability to market special Continuing Education courses directly to students, allow students to browse offerings across colleges, as well as maximize the efficiency of college Continuing Education staff so that they can focus on developing new offerings, expanding partnerships with industry leaders, and rapidly respond to emerging workforce development needs.

**VENDOR SELECTION CRITERIA:**

Pursuant to State Law, purchases and contracts for the use, purchase, delivery, movement or installation of data processing equipment, software, or services and telecommunications and inter-connect equipment, software and services are exempt from the District's competitive bidding requirements.

Contingent Liability – Pursuant to Section 7-14 of the Illinois Public Community College Act, all agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal year is subject to appropriation in the subsequent fiscal year.
