ORIGINAL TERM:

In accordance with Board Report #34683, the original term of the agreement commenced on February 1, 2023, and shall end on March 31, 2026, with an option to renew for an additional two (2) two-year periods.

FIRST RENEWAL TERM:

The first renewal term of this agreement shall begin on April 1, 2026, and shall end on March 31, 2028, with an option to renew for an additional one (1) two-year period.

SCOPE OF SERVICES:

The selected vendors will provide staff and professional services for short- and long-term engagements in the following categories:

- Web Development and Design
- Data Warehouse
- Business Intelligence
- WordPress Support
- Projects related to CCC's Enterprise Constituent Relationship Management (CRM) system (Salesforce) which may also include:
 - Third-party Salesforce integrations
 - Marketing Cloud and/or Pardot projects
 - Valence ETL tool
 - Tableau and/or Datorama
 - Integrations with other CCC platforms and infrastructure
 - Salesforce development and administrative tasks
 - Salesforce training and end-user support

BENEFIT TO CITY COLLEGES OF CHICAGO:

This slate of agencies and vendors is targeted to our emergent needs in the areas of CRM, Web Design, Web Development, and our data warehouse. Having this pool of vendors to provide staff augmentation, implementation and agency services will allow CCC to respond to stakeholder needs in a timely fashion, leveraging expertise from across our industry.

VENDOR SELECTION CRITERIA:

Specifications were prepared by District Procurement staff and publicly advertised on July 13, 2022, as Request for Proposal (RFP) #NC2201 – Salesforce, Business Intelligence & Web Development and Design Staff Augmentation Services. The RFP was sent to twenty-four (24) firms, and a pre-proposal conference was conducted on July 19, 2022. Submittals were received on August 25th, 2022, from the following thirty-two (32) vendors: 1) 22nd Century Technologies Inc.; 2) Agreeya Solutions Inc.; 3) Arkus Inc. (Non-Responsive); 4) Arthur Lawrence Management LLC; 5) California Creative Solutions Inc.; 6) Clarity Partners LLC; 7) Cogent InfoTech Corp.; 8) Compunnel Software Group Inc.; 9) Compu-Vision Consulting Inc.; 10) Dynamic Interactive Business systems Inc.; 11) Enterprise Solutions Inc.; 12) Executive Consultant United LLC; 13) FAAZ Consulting LLC; 14) Infoway Solutions LLC; 15) Infojini Inc.; 16) InstantServe LLC; 17) LanceSoft Inc.; 18) MakeSense Inc.; 19) Mavensolve LLC; 20) NatSoft Corp.; 21) PlumLogix Inc.; 22) Productivity Modeling Corp.; 23) Servio Consulting LLC; 24) Slalom LLC; 25) SoftSages Technology; 26) Spruce Technology Inc.; 27) The Midtown Group; 28) Tryfacta Inc.; 29) V-Group Inc.; 30) VisionPoint Marketing LLC; 31) V-Tech Solutions; and 32) Zion Cloud Solutions LLC. Of those, one (1) vendor, Arkus, Inc was deemed unresponsive for not submitting in accordance with the RFP requirements. All responsive proposals were reviewed, evaluated, and ranked by the evaluation committee, which included staff from the office of Information Technology, Marketing and Communications, and the Chancellor's Office.

The firms were evaluated according to the following criteria:

1. Qualifications and experience of firm
2. Past experience with similar services for higher educational institutions or comparable organization's entities.
3. Demonstrated ability to provide services as outlined in the scope of services and responses to interrogatories
4. Pricing Proposal

5. MBE/WBE compliance
