THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair, upon final approval of the General Counsel of the legal form of such agreements, to exercise agreements with the vendors listed below for employee recruitment services for the period from February 5, 2026 through February 5, 2027, at a total cost not to exceed \$285,000 for the term of the agreement.

TERM:

In accordance with board report 34719, the term of this agreement began on February 2, 2023, and will have ended on February 1, 2026, with an option to extend for an additional two (2) 1-year periods.

FIRST RENEWAL TERM:

The term of this agreement shall begin no sooner than February 5, 2026, and shall end on February 4, 2027, with an option to renew for an additional one (1) 1-year period.

SCOPE OF SERVICES:

The vendors will recruit experienced individuals for permanent positions on an as-needed basis.

- Provide search services for City Colleges of Chicago for the recruitment of employees that meet the minimum qualifications, education, and experience set by the City Colleges of

Chicago for employees for administrative, accounting, financial, legal, managerial, marketing, procurement, professional technology, and academic services

- Review position profile in consultation with the hiring authority and CCC's Human Resources team;
- Distribution of e-mails to members of the firm's proprietary database and their own resources to identify and cultivate a pool of professional candidates to present to City Colleges of Chicago for consideration;
- Provide resumes and credentials of qualified candidates to the City Colleges of Chicago for review;
- Assist in coordinating all applications, interview, notifications, and potential offers for position; and
- Notification to those candidates not selected for advancement to the interview.

BENEFIT TO CITY COLLEGES OF CHICAGO:

The Office of Human Resources and Staff Development has determined it would be in the best interest of the District to execute contracts with the above-mentioned staffing firms to ensure adequate and continuous specialized staffing on an as needed basis.

VENDOR SELECTION CRITERIA:

Specifications were prepared by District Procurement staff and Bid #MWJ2203 was publicly advertised on August 24, 2022, and issued to thirty (30) companies. A pre-bid was held on August 30, 2022. Eight (8) companies responded on September 30, 2022: 1) 22nd Century Technologies, Inc.; 2) LanceSoft, Inc.; 3) Compunnel Software group, Inc. dba Compunnel, Inc.; 4) Infojini, Inc.; 5) ManpowerGroup, Inc.; 6) Anchor Staffing, Inc.; 7) LaSalle Staffing, LLC dba LaSalle Network; and, 8) M & M Staffing Agency. M & M Staffing Agency is deemed non-responsive for failure to comply with the submittal requirements.

The vendors were asked to provide maximum fees for recruitment services for any position at no more than 30% for the first-year annual salary at the time of hire, which excludes benefits. All bids were reviewed by staff from the Office of Human Resources. Staff recommends the acceptance of bids received from the following overall lowest and most responsive vendors listed based on the following fees per annual salary per category:
