THE CHANCELLOR RECOMMENDS:

That the Board of Trustees authorizes the Chair, upon final approval of the General Counsel as to the legal form of such agreement, to execute an agreement with McGraw Hill, LLC to provide college placement math services for the period commencing July 9, 2026, through July 8, 2027, at a total cost not to exceed \$1,125,000.

ORIGINAL TERM:

The term of this agreement shall commence no sooner than July 9, 2026, and continue through July 8, 2027.

SCOPE OF SERVICES:

McGraw Hill will continue to provide ALEKS PPL, a computer adaptive math testing for credit student placement of new students. ALEKS PPL has demonstrated great accuracy and predictive validity in math placement and provides multiple opportunities for students to learn and improve their scores.

BENEFIT TO CITY COLLEGES OF CHICAGO:

ALEKS PPL provides not only placement indication for math but diagnostics that allow instructors to not only know that a student should be placed in Math 118 but that the student requires additional help with solving linear equations

VENDOR SELECTION CRITERIA:

In accordance with sole source policy procedures, this service is exempt from the district's competitive bidding process.

MBE / WBE COMPLIANCE:

The Office of Procurement Services has reviewed the proposed compliance plan and recommends a full waiver of the Board Approved MBE/WBE Contract Participation Plan due to the nature of the agreement (diagnostic placement tool for mathematics) and the absence of subcontracting opportunities.

GENERAL CONDITIONS:

Inspector General – It shall be the duty of each party to the agreement to cooperate with the inspector General for City Colleges of Chicago in any investigation conducted pursuant to the Inspector General’s authority under Article 2, Section 2.7.4(b) of the Board Bylaws.

Ethics – It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board’s Ethics policy adopted January 7, 1993, and as amended by the Board.

Contingent Liability – Pursuant to Section 7-14 of the Illinois Public Community College Act, all agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal year is subject to appropriation in the subsequent fiscal year.
