RESOLUTION
COMMUNITY HEALTH PARTNERSHIP CERTIFICATION
MALCOLM X COLLEGE

WHEREAS, the Board of Trustees of Community College District No. 508, County of Cook and State of Illinois (“City Colleges of Chicago”), on behalf of Malcolm X College, seeks to establish partnerships that support community health initiatives and expand services to underserved populations throughout the Chicago area; and

WHEREAS, the National Quality Improvement Community Health and Compliance Institute (“NQICHCI”), an Illinois 501(c)(3) nonprofit organization, operates in partnership with healthcare systems, governmental entities, and community organizations to support value-based care transformation, behavioral health integration, and healthcare access for vulnerable populations; and

WHEREAS, Malcolm X College and NQICHCI desire to enter into a Community Health Partnership Certification Agreement whereby Malcolm X College will provide ministerial administrative certification services related to quarterly expenditure reports prepared by NQICHCI in support of mandatory state reporting requirements; and

WHEREAS, pursuant to the Agreement, NQICHCI shall provide Malcolm X College with partnership support payments in the amount of Twenty-Five Thousand Dollars (\$25,000.00) per quarter, for a total annual amount of One Hundred Thousand Dollars (\$100,000.00), in recognition of the Institution’s partnership and administrative support services; and

WHEREAS, the Agreement further provides that NQICHCI shall defend, indemnify, and hold harmless City Colleges of Chicago, Malcolm X College, and their officers, employees, and agents from and against any claims, liabilities, damages, losses, or expenses arising out of or related to the expenditure reports or NQICHCI’s clinical operations; and

WHEREAS, the Agreement shall commence on May 1, 2026, and continue for a period of five (5) years, unless earlier terminated by either party upon thirty (30) days written notice, with the option to extend for an additional five (5) year term upon mutual agreement of the parties;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of Community College District No. 508, County of Cook and State of Illinois hereby approves the

Community Health Partnership Certification Agreement between Malcolm X College and the National Quality Improvement Community Health and Compliance Institute for the period beginning May 1, 2026 through April 30, 2031, with partnership support payments to Malcolm X College in the amount of \$100,000.00 annually, payable by NQICHCI in quarterly installments of \$25,000.00, in accordance with the terms and conditions of the Agreement.
